# **CALL TO MEETING**

# **REVIEW AND APPROVE PRIOR MEETING MINUTES**

Ryan Drepaul made a motion to approve the September 6, 2022 Board of Directors meeting minutes. The motion passed unanimously.

#### **NEW BUSINESS**

- Budget 2024 Motion to approve the budget proposed by Ryan Depraul, seconded by Rodrigo Dominguez. Motion passed unanimously.
- Pool chair lift Brian is working with the OEM, awaiting proposal from vendor.
- Area sidewalk repairs Travis County owns the sidewalks and has made a number of repairs since our last meeting. Repairs are still ongoing. The HOA has the ability to supplement county repairs if desired. Rodrigo Dominguez motions to table this until the next meeting to see how much progress has been made, seconded by Ryan Depraul. Motion passed unanimously.
- Pond Rehab Pond rehab is underway, additional work will be done on clarifying how the ponds are titled and ensuring they fall under Brookfield responsibilities.
- Community social functions Ryan gave an update on social functions, noted lack of volunteers has led to a lack of events. Also noted the board is exploring reaching out to a partner to help plan potential events and will explore pros and cons of utilizing Goodwin's event planning expertise.
- Playground Pergola Pergola by the Northwestern most corner of the norther traffic circle collapsed, the debris was removed and the cause was found to be due to deterioration. The other pergola may also be deteriorating. The board has decided to obtain quotes on replacing the pergolas.
